

**Gilbert Plains Municipality By-law No. 2021-03**  
**Being a By-Law to provide for the remuneration of members of Council.**

WHEREAS Section 124 of the Municipal Act, being S.M. 1996, c.58, provides that a Council may by by-law set the types, rates and conditions of payments to be made to or on behalf of members of the Council and Council committees,

- a) as compensation for attending to municipal business;
- b) for expenses incurred while attending to municipal business; and
- c) for any other purpose relating to municipal business that the Council considers appropriate.

NOW THEREFORE, the Council of the Gilbert Plains Municipality enacts as follows:

- 1) THAT the Reeve shall be paid the sum of \$900.00 per month.
- 2) THAT the Councillors shall be paid the sum of \$800.00 per month.
- 3) THAT the Reeve and Councillors shall be paid \$30.00 per day for attending meetings within the Municipal boundaries and \$60.00 per day for attending meetings outside of these Municipal boundaries.
- 4) PLUS \$.44 cents per kilometer for travel in regard of attending meetings and the supervision of work to and from their respective places of residence.
- 5) WHERE the Reeve or Councillor is paid remuneration from the Committee they represent, then no further claim shall be paid by the Municipality to attend such meetings.
- 6) THAT the Reeve and Councillors shall be paid an additional \$15.00 per hour for supervising work in the Municipality.
- 7) THAT each member of the Council duly authorized by resolution of Council to conduct business beyond the limits of the municipality shall be reimbursed the following meal allowance:

Breakfast	\$ 20.00	(leaving home prior to 7:00 AM)
Lunch	\$ 20.00	
Supper	<u>\$ 20.00</u>	(arriving home later than 6:00 PM)
	\$ 60.00	
- 8) WHERE the Reeve and Council are required to attend as delegates to conventions, they shall be paid as follows:
  - \$100.00 per full day in attendance plus board and lodging
  - \$15.00 per hour for travel to/from when travel occurs on the day before or after the convention or for attendance at a convention that only covers part of the day.
  - \$.44 cents per kilometer for transportation to and from their respective residence when only one member of Council is required to attend. When more than one member is required to attend then they will be paid one way unless they carpool.
- 9) WHERE the Reeve and Council are required to have consistent communication though technical means, they shall be reimbursed as follows:
  - \$75.00 maximum per month technical expense.
